### Guidelines for Submission of Papers

- (1) Articles should be type-written with double-line spacing one face only, not more than 15 pages of A4 paper including references, diagrams, pictures and appendices on 12 font size, Times New Roman font style and the new APA Referencing style.
- (2) The cover page should bear the title of the Paper/Article, the author's(s') name(s), affiliation(s), e-mail address(s) and phone number(s).
- (3) Article should be accompanied with an abstract of not more than 250 words containing statement of problem, methodology, findings and recommendations/contribution to knowledge.
- (4) A soft copy of the paper/article should be sent online as an attachment to [ijbmruunizik@gmail.com](mailto:ijbmruunizik@gmail.com).

- (5) All manuscripts shall be peer reviewed to ensure accuracy and relevance. A manuscript will be accepted for publication sequel to the referees' recommendations.
- (6) Those whose papers are accepted for publication will be required to pay a sum of Twenty Thousand Naira (N25, 000) or Fifty US Dollars (\$50) publication fee.
